SHRINE OF THE MOST HOLY REDEEMER Las Vegas, Nevada

The Shrine of the Most Holy

Redeemer was established in 1991 and The Reverend Phil Audet is its Rector. Most Reverend Joseph A. Pepe., D.D., J.C.D., is Bishop of the Diocese of Last Vegas, Nevada. The Shrine is the largest Roman Catholic Church in the State of Nevada, with seating for over 2,200 worshippers. The Shrine's beautiful main altar is shown in the photo above. The altar, lectern, sanctuary lamp, crucifix, and tabernacle are original contemporary works in bronze.

Within the Shrine is housed the lovely Our Lady of Guadalupe Chapel. The Chapel was commissioned by the Most Reverend Daniel F. Walsh, D.D., former Bishop of the Diocese of Reno-Las Vegas, to celebrate the 500th Anniversary of the Evangelization of the Americas. The Chapel is a gift of the E.L. Wiegand Foundation. The Chapel contains a beautiful oil painting of Our Lady of Guadalupe, which originated in Mexico in the late 17th Century (circa 1680). Also in the Chapel is a four-foot, hand-carved statue of St. Joseph and the Child Jesus. The statue is approximately 200 years old and has been completely restored. The most contemporary artistic work is a mural depicting all of the people of Canada, the United States, Mexico, Central and South America who played a significant role in the Evangelization of the Americas.

Worship in this beautiful edifice and house of God will truly be an inspiration to the LPSCU fraternal family and guests as during the Liturgy we invoke God's blessings upon the delegates to our National Convention.

This past April 15-20, the United States of America was blessed by a pastoral visit from His Holiness, Pope Benedict XVI. This was his first visit to America since being elected to the papacy. The Pontiff's theme for his pastoral visit was *Christ Our Hope*. It can be safely said that this particular theme was drawn from Pope Benedict's second encyclical entitled, **Saved In Hope (Spe Salvi)**. As we did with his first encyclical, **God is Love**, let us spend some time reflecting on this beautifully positive writing.

"In hope we are saved," Pope Benedict begins his encyclical, quoting from Saint Paul's Letter to the Romans (Romans 8:24). Merriam-Webster's on-line dictionary defines *hope* as: "desire accompanied by expectation of or belief in fulfillment." For Catholics, hope, along with faith and love, is considered to be one of the three great theological virtues. In

paragraph 1817, the *Cathechism of the Catholic Church* says: "The virtue of hope involves desiring the joy of eternal life with God above everything else and depending on God's grace, rather than on our own strength, on that journey." Hope calls us to live our lives in anticipation of that

moment when we will be drawn into the fullness of life and love with God in heaven. But, until that moment of ultimate fulfillment comes, we rely on God's grace to stay focused on what is expected of us as we journey to heaven.

In his encyclical, Pope Benedict certainly encourages us to have this very positive attitude towards hope, but he also acknowledges that living a life of hope in a world filled with many distractions which can pull us down is quite a challenge. He reminds us that there are many voices in the world trying to convince us that God isn't real or that the Church is not necessary for our salvation. Advances in science and technology seem to call us to place our hope more in human achievement and progress than in the providence of God in our lives. In light of all the "stuff" and "toys" that we have in life, we can easily lose our sense of dependence on God and see the human person as the be-all and end-all of reality.

In his work, Pope Benedict highlights three very important characteristics of hope:

1. **Hope is rooted in Jesus Christ**. In paragraph 6, he says: "The true shepherd is one who knows even the path that passes through the valley of death; one who walks with me even on the path of final solitude, where no one can accompany me, guiding me through; he himself has walked this path, he has descended into the kingdom of death, he has conquered death, and he has returned to accompany us now and to give us the certainty that, together with him, we can find a way through."

2. **Hope changes our lives**. In paragraph 31, we read: "God is the foundation of hope; not any god, but the God who has a human face and who has loved us to the end, each of us and humanity in its entirety. His Kingdom is not an imaginery hereafter, situated in a future that will never arrive; his Kingdom is present wherever he is loved and wherever his loves reaches us." Hope encourages us

to believe that a new situation, a new beginning is always available, if we choose to seek that beginning.

3. **Hope unites us to others in Christ**. In paragraph 48, the pope asserts: "Our hope is always essentially also hope for others; only thus is it truly hope for me too. As Christians, we should never limit ourselves to asking: How can I save myself? We should also ask: What can I do in order that others may be saved and that for them too the star of my hope may rise? Then I will have done my utmost for my own personal

salvation as well."

These characteristics of hope remind us that Christianity is not a private event, not something isolated solely to the individual person. Being Christian means that we cannot live by an "anything goes" mentality. Christianity differs from those schools of thought which leave all moral

and ethical decisions up to the individual. We live in community, informed by God and challenged to put God's will above our own. While we are called to make choices and decisions in life, these must be made in accord with God's commandments and expectations, especially as these have been articulated through the Church.

We place our hope in many things in life, great and small. But "things" ultimately fail us. Pope Bendict reminds us that we can and do have hope in our personal efforts or relationships and these bring us happiness, but only for a time. Our world invites us to have hope in great material and scientific achievements and these are quite good, but as we have seen in recent history, these achievements also have the power to cause great destruction and harm the human spirit. In the midst of much progress, human beings can still be sad and lonely, drifting along through life as if they have no hope. Our Christian faith tells us that we can't place our ultimate hope in the things of this world. The only sure hope is that which God — who is eternal, unchanging and faithful truth, love and life — offers us.

Pope Benedicts offers us three major ways that we learn and practice the virtue of hope and allow it to take deeper root in our lives:

1. **Prayer**. In prayer, we can always talk to God, even when there is no source of human hope. To make room for hope, we must make room and develop a capacity for listening to God.

2. **Action and suffering**. Our actions of love and service teach us hope. Our hope in God and his greater

Convention Donations Notice

The LPSCU Convention, to be held July 22-24, 2008, in Las Vegas, Nevada, will consider applications for donations.

Donation applications are available upon request through the Home Office. Qualified representatives of organizations seeking donations may contact the Home Office for an application. Applications are also available on the LPSCU web site, <u>www.lpscu.org</u>.

All requests for donations from the Convention must be submitted on an LPSCU Donation Application Form and must be returned to the Home Office with a postmark of no later than **May 15, 2008**.

ATTENTION: ALL MEMBERS ASPIRING FOR LPSCU NATIONAL OFFICE

According to the Official Minutes of the Board of Directors' Semiannual Meeting held in Las Vegas, Nevada, on November 6-8, 2007, it is required that any member with aspirations for National Office must request an Intent Form from the Home Office. According to the LPSCU Bylaws, the qualifications for candidates are set forth in the following Articles:

<u>Article 16</u>. A candidate for office must be at least 21 years of age, an active member with participation in LPSCU Branch or District activities for at least five years, and be present as a delegate at the Convention.

<u>Article 17</u>. No two immediate family members shall serve as an Officer of the LPSCU during the same term of office. Immediate family is defined as: grandparent, parent, spouse, or sibling.

<u>Article 18</u>. A member or delegate who is a National Officer/Director/Board Member of another fraternal benefit society may not hold office of the LPSCU.

<u>Article 26</u>. No hired employee of the LPSCU shall be eligible to hold any National Office in the LPSCU while so employed, with the exception of the office of Secretary/Treasurer.

<u>Article 27</u>. Since the office of President is full time, nominations for this office will not be made from the floor. Nominations for the office of President shall be by written application which states the nominee's qualifications, personal background and history, as well as past experience. Nominee applications are to be submitted to Home Office two months prior to the Convention. The Board of Directors shall verify these qualifications. They may use personal interviews, a professional investigating company, or any other means in order to verify the qualifications. From these applications, the Board of Directors shall recommend to the Nominating Committee candidates qualifying for the office of President.

<u>Article 28</u>. While nominations from the floor are to be accepted for all National Offices, excluding the office of National President and the hired position of Secretary-Treasurer, upon acceptance of the nomination, nominee will provide a resume to the delegates of the National Convention, containing personal background and history, and past experience, to prove their qualifications for the office to which they have been nominated.

The completed Intent Form must be returned to the Home Office with a postmark no later than **June 6**, **2008**, with the exception of the Intent Form for the office of President, which must be returned to the Home Office with a postmark no later than **May 22, 2008**.

PEACHES AND CREAM CHEESE CAKE

³/₄ cup flour 1 tsp. baking powder ½ tsp. salt 3 tsp. margarine 1 egg $\frac{1}{2}$ cup milk 3¹/₂ oz. pkg. dry vanilla pudding (not instant) 20 oz. can sliced peaches, drained (reserve juice)

Filling

8 oz. cream cheese 3 Tbsp. peach juice ¹/₂ cup sugar

Topping

1 Tbsp. sugar

degrees for 30 to 35 minutes.

1/2 tsp. cinnamon

Combine flour, vanilla pudding, baking powder, egg, salt, milk, and margarine and beat for two minutes at medium speed. Pour mixture into a greased 9" pie pan. Place the drained peaches over the batter. Combine cream cheese, sugar, and peach juice and beat for two minutes at medium speed. Spoon the cream cheese mixture to within 1" of edge of batter in pie pan. Combine sugar and cinnamon and sprinkle over the cream cheese filling. Bake at 350

With a lump in my throat and a tear-stained paper, I began ...

I don't think she'll be listening, cause Mom's too far away Still there isn't any reason I can't send my love today.

Some years ago I loved her, as any child might But now that I'm a mother that love takes on new light.

Only now can I appreciate the times she chastised me Or the other precious moments when she held me on her knee.

Only now can I realize the heartaches that she bore When Dad came down with asthma and he could work no more.

His illness was a lingering one and Mom she bore her cross Until one day she realized she must suffer her first great loss.

He passed away real quietly in the middle of the night Her role as that of Mother must now take on new light.

She worked for eight long years to put us all through school *My Mom* — *a real precious jewel!*

His favorite pastimes are playing basketball and golf, and fishing. He also enjoys working at his family's miniature golf course.



Vincent Obsitnik is New Ambassador to Slovakia

Vincent Obsitnik was recently sworn in as the sixth U.S. Ambassador to the Slovak Republic. He is the first Ambassador to Slovakia who is of Slovak heritage. Born in Moravany, a small village in eastern Slovakia near Humene, he emigrated at the age of two months to Nanty Glo, Pennsylvania. The family later moved to New Jersey. The new ambassador has also lived in Connecticut, New York, Virginia, Georgia, and Florida.

Vincent and his brother, as well as two of his four sons are graduates of the U.S. Naval Academy. He also received a master's degree from The American University.

The new Ambassador's business career includes serving as director of manufacturing for Latin America at IBM Corporation; as president of the System Development Division of Unisys/Loval Corporation; and as vice president of international development at Litton/PRC Corporation. He recently served as a member of the United States Commission for the Preservation of America's Heritage Abroad.

Dear Junior Members,

May is a lovely time of the year. You begin to hear birds chirping and see them fluttering from branch to branch, bringing food to their young ones. We all enjoy hanging birdhouses, filling our birdfeeders, and watching the beautiful birds.

But there is one bird that we do not welcome as we do the others — the American Crow. Perhaps that's because of its noisy "caw" and because it is not as pretty or colorful as the songbirds that flock to our feeders. This large bird with dark brown eyes and black legs can stand 16 to 21 inches in length and have a wingspan of 33 to 39 inches. Covered in black feathers glossed in violet, male and females crows look identical, though the males are generally a bit larger. Crows are black for



a very good reason — so they can identify their own kind. During the day, a crow can easily identify another crow in the distance because black is very visible. And at night, when crows are the most vulnerable, the black coloration helps to protect them from predators.

In spite of their dour appearance, crows are very bright. To quote Henry Ward Beecher, "If men wore feathers and wings, very few of them would be clever enough to be crows."

Crows — along with their fellow members of the Corvidae family, Ravens — are believed to be the most intelligent of all birds, so it's little wonder that they have been revered over the centuries. Sometimes their intelligence leads them into thievery and mischief. A crow thinks nothing of stealing another's nesting material while the other crow is out searching for food.

Crows are very social in nature. Their interaction with their own kind is very important to them. Young crows remain with their parents until they can find a home of their own, and individual relationships may last years. Families may include up to 15 individuals and contain young from five different years.

Crows usually mate for life. They are cooperative breeders with both parents taking turns to sit on the eggs. All family members help when nesting season arrives, the juveniles from prior years along with their parents helping to gather nesting material. The number of eggs in a clutch or nest is usually 4 to 6.

Crows congregate in large numbers in winter to sleep in communal roosts. These roosts can be of a few hundred, several thousand, or even up to two million crows. Some roosts have been forming in the same general area for well over 100 years

The crow is tough, resourceful, and crafty, and above all other birds, they know how to survive against heavy odds. One major reason is their amazing communication system. Not only do they seem to have built-in radar for detecting danger, but they communicate with one another with a relay system. Through not understood by humans, it is crystal clear to crows. They will pass the word along and let each other know that there is food nearby. A farmer once noted that he put out poisoned corn to get rid of the crows that were eating his grain, but he learned that within minutes they had spread the word to one another to stay clear of the area.

In addition to their relay systems, crows have an uncanny sense of caution. They will appoint a sentinel to stand guard while they are on a hunt for food. They can spot a gun barrel a half mile away and they will never confuse it with a stick or pole. They can make a hasty retreat in absolute silence at speeds of up to 45 miles an hour.

Crows have extremely good

memories. They never forget where they placed their cache of food for later consumption. Despite being a common exploiter of road kill, the crow is not specialized to be a scavenger, and carrion is only a very small part of its diet. Their biggest natural enemies are hawks and owls and it's not uncommon to see a family of crows vocally harassing and chasing a lone hawk in the air or mobbing a perched owl to chase it out of their territory. Man is another enemy of the crow, especially those who hunt them. But more recently, crows have had to contend with an even more serious threat: the West Nile virus. The American Crow appears to be the biggest victim this disease recently introduced to North America. Crows die within one week of infection, and few seem able to survive exposure. No other North American bird is dying at the same rate from the disease, and the loss of crows in some areas has been severe.

For centuries bird lovers and hunters/farmers have argued about whether crows do more harm than good, but no one argues the fact that the crow is one of the most remarkably intelligent birds on the planet.

Kids in the Kitchen

SPROUT A BEAN

Bean sprouts are fun to grow and they are delicious added to your salad. Here's what you'll need to grow your own:

> An empty glass jar A piece of cheesecloth (or punch holes in the jar lid) A rubber band

1-2 tablespoons mung beans or soybeans

Rinse off the beans and then put them in a layer in the bottom of the jar. Cover them with water and let them soak overnight. The next morning, place the cheesecloth on top of the jar, securing with a rubber band (or screw the lid onto the jar). Pour off the water. Rinse the beans in cool water and lay the jar on its side in a dark place. On the third or fourth day, place the jar in the sunlight and the sprouts will turn green. Then you will be able to add the sprouts to your salad.

Sunflower Facts

If you stood next to a sunflower plant, there's a good chance it would be much taller than you. The common sunflower grows to about 8 feet tall, but the tallest kind of

sunflower reaches 15 to 20 feet in height. That's about as tall as a giraffe!

The sunflower blossoms at the end of the summer and into early autumn. Sunflowers get their name because each morning they will turn their face



toward the sun. All day long they follow the sun across the sky and end up facing west in the evening.

But the sunflower is more than just a pretty face. In fact, it is the second most important oil-producing crop in the world. Sunflower oil is used to make salad oil, margarine, soap, candy, and paint. It is also used in cooking. Sunflower oil has been used as fuel to run diesel motors in Africa and Australia.

Non-oil producing sunflower plants provide seeds that people eat in salads, sandwiches, or by themselves. They are also an important source of bird feed.

If you planted just one sunflower seed, the flower that would grow from it would produce over one hundred seeds!

Plant a sunflower seed in a sunny spot in your garden. Try to plant it near a fence for support. It will be fun to watch it grow, and to also watch the birds it attracts.

Remembering Those Who Sacrificed

Memorial Day, originally called Declaration Day, was first celebrated on May 30, 1868. Major Gen. John A. Logan, commander-in-chief of the Grand Army of the Republic, an organization of former Union soldiers and sailors, ordered his members to decorate the graves of fallen comrades with flowers and to protect the gravesites from the ravages of time and



weather. In 1971, Congress expanded Memorial Day to include all members of the Armed Services who have died in service to our country.

Memorial Day is observed annually on the last Monday of May. This Memorial Day — May 26th — we will pause for a moment and remember all our heroes who have made the ultimate sacrifice in all our wars. We will also remember the families of those who served and died to protect our freedom and way of life. May God bless them.

purposes give us the courage to follow him and bring goodness and justice into this broken world (paragraph 35).

Suffering, too, teaches us hope because in moments of suffering, we know that we are not alone. Jesus is our companion and our suffering is joined to his. In such moments, we are encouraged to offer up our suffering. Those who do so are convinced that they can insert their burdens into Christ's great *compassion* so that even the inconveniences and crosses of daily life can acquire meaning and contribute towards the good and well-being of others.

3. **Final Judgment**. In a world filled with suffering and injustice, it is tempting to lose hope and wonder where God could be in such a place. Pope Benedict teaches that even in the midst of all this injustice, there is reason for hope: the Final Judgment and the coming together of all things in Christ. Our only and final hope is in the God who made us and whom we trust will bring us back to him forever. When confronted by the difficulties of this life, people will often say, "There's got to be more than this!" The "more" we seek is promised to us in eternity, if we faithfully and generously serve God now.

Throughout his deep and profound encyclical, Pope Benedict encourages us to be "ministers of hope" in our world today by living lives that are centered on the needs of others. In order to combat the negativity that we sometimes find around us, we must truly live and share the beauty of our Christian faith — especially as we follow Jesus' command to love. Living lives of joyful expectation of the fulfillment that is yet to come, may we work to reshape the world around us into a gift pleasing to the Lord!
