

# Spiritual Advisor's Message

"Regret City"

I cannot change yesterday, but I

do have the power to make today

a wonderful day!

Recently, while reading through a website devoted to sharing motivational stories (<a href="www.motivational-well-being.com">www.motivational-well-being.com</a>), I came across a story that I had never seen before. It was simply entitled "Regret City," and is attributed to an anonymous author. As we journey through this holy season of Lent, a time of spiritual growth and new beginnings, please allow me to share this story with you. I encourage you to read this story very carefully and slowly . . .

I had not really planned on taking a trip this time of year, and yet I found myself packing rather hurriedly. This trip was going to be unpleasant and I knew in advance that no real good would come of it. This is my annual "Guilt Trip."

I got tickets to fly there on "WISH-I-HAD" airlines. It was an extremely short flight. I had my "personal baggage," which I could not check. I chose to carry it myself all the way. My baggage was loaded down with a thousand memories of "what might have been." No one greeted me as I entered the terminal to the Regret City International

Airport. I say international because people from all over the world come to this dismal town.

As I checked into the "Last Resort" Hotel, I noticed that

they would be hosting the year's most important event – the annual "Pity Party." I was not going to miss that great social occasion. Many important families and individuals would be at the party.

First, there would be the "Done" family; you know – "Should Have," "Would Have," and "Could Have." There would be the "I Had" family – good old "Wish" and his clan. Of course, the "Opportunities" family, "Missed" and "Lost," would be present. The biggest family there would be the "Yesterday's." There are far too many "Yesterday's" to count, but each one would have a very sad story to share.

Of course, "Shattered Dreams" would surely make an appearance. The "It's Their Fault" family would regale us with stories (excuses) about how things had failed in their lives because of others. Each story would be loudly applauded by the "Don't Blame Me" and the "I Couldn't Help It" clans.

To make a long story short, I went to this depressing party, knowing full well there would be no real benefit in doing so and I became very depressed. But as I thought about all of the stories of failures brought back from my past, it occurred to me that this trip and subsequent "pity parties" COULD be cancelled by ME!

I started to realize that I did not have to be there. I did not have to be depressed. One thing kept going through my mind: I cannot change yesterday, but I do have the power to make today a wonderful day! I can choose to be happy, joyous, fulfilled, encouraged, as well as encouraging to others.

Knowing this, I left Regret City immediately, and did not leave a forwarding address. Am I sorry for mistakes I have made in the past? YES! But there is no way to undo the mistakes; yet I can learn from them, so as not to commit them again.

So, if you are planning a trip back to Regret City, please cancel all those reservations now. Instead, take a trip to a nice place called "Starting Again." I like it so much that I made it my permanent residence. My new neigh-

bors, the "Been Forgiven" and the "We're Saved" families, are so very helpful.

By the way, you do not have to carry around the heavy personal baggage anymore either. That load is lifted from your shoulders upon arrival. But don't take my word for it, find out for yourself.

It is probably safe to say that all of us, at one time or another, have embarked on a trip to Regret City and we have encountered the various situations and "families" that are described in this symbolic story. We have all thrown "pity parties" for ourselves and have looked back, with regret, on

> things that we have said or done that have been hurtful and harmful. Some of us have blamed others, unwilling to accept personal responsibility for what has happened in our lives.

Towards the end of this story, the "traveler" begins to realize that he has the power to begin to change how he approaches his situation in life. The traveler can choose to allow himself to be overwhelmed by feelings of guilt, regret, or sadness, or the traveler can choose to allow a more positive attitude about life guide him as he journeys to a much more healthy and safe destination. Certainly there are some "externals" about life that we cannot control or change, but we can control the approach or attitude that we take to what we experience in life and, where necessary, make the appropriate self-changes that can help us experience more joy and happiness in life.

During the season of Lent, we are given an opportunity to learn from our past and open our hearts and lives to the transforming power of God's mercy. Lent affords us the opportunity to "begin again" in our various relationships. Most importantly, through the Sacrament of Reconciliation or Confession, we are invited to embrace the gift of new life that comes from the experience of forgiveness. When we approach the Sacrament of Reconciliation, voicing and expressing our sins allows us to talk about what we have said or done to harm relationships, not to simply relive the past, but to learn from past hurts and mistakes.


Sacramental confession is a chance to talk about what may be tearing us up inside. In order to experience true forgiveness, we must be honest and vulnerable about who we are and what we have done...the good and the bad. Some people believe that if they just pretend that something never happened, maybe it will all just go away. While this may sound nice, it is not true. Sometimes we need to be honest

Dear Sisters and Brothers of the LPSCU:

The Ladies Pennsylvania Slovak Catholic Union is one of two Slovak fraternals that list me as its Protector. I value that honor and distinction very much. Such a position is intended to provide a somewhat official connection with the Church – to intercede for the Society, if necessary. 

### Slovak Summer Institute Schedules Slovak Courses

The intensive Slovak Summer Institute will again be held at the University of Pittsburgh from June 4-13, 2012. Beginning, Intermediate, and Advanced Slovak will be offered. This course is open to students of any age, including juniors and seniors in high school, undergraduate and graduate students, as well as persons of any age not currently enrolled in a college or university. Partial and full scholarship aid is available. (Apply by March 16 for scholarship consideration.)

The Summer Language Institute consists of intensive instruction (five hours daily), allowing students to make the greatest possible progress in Slovak during the time available. SLI's Intensive Slovak courses, which carry six college credits, are a thorough introduction to the basic categories of Slovak pronunciation, grammar, and syntax. Emphasis is placed on the communicative competence, the active use of new structures in dialogues, unstructured conversation, reading, and listening comprehension. Guest students may choose to stay in a dormitory or in a subleted apartment.

A four-week intensive Slovak language program at the intermediate level will be offered through SLI in 2012 in Bratislava, Slovakia, following the six-week program in Pittsburgh. This course includes travel and cultural programs in Slovakia. Applicants with some prior knowledge of Slovak may also be considered for participation in this program.

#### \$150 One-Time Award

The LPSCU is offering a Catholic High School Award Benefit, which is a \$150 one-time award to our members who are attending a Catholic high school during the 2012-2013 academic year. Members may only receive this award one time.

The following are the guidelines for applying for the Catholic High School Award:

- Must be a member of the LPSCU for two (2) years with \$2,000 permanent reserve life insurance certificate (excludes term insurance).
- Must be a Catholic high school freshman, sophomore, junior, or senior.
- Must provide a wallet-size color photo.

Applicants must meet all criteria and provide data indicated above to be eligible. Incomplete applications or those missing data requirements will not be considered. All materials become the property of the LPSCU and will not be returned. **Applications must be postmarked by June 30, 2012.**



- Be active in an organization or activity that promotes awareness of our Slovak heritage, culture, and traditions.
- Be endorsed by their pastor and LPSCU Branch Secretary, with additional endorsement provided by campus minister, youth minister, or pastoral associate.
- Attend (or will attend) an accredited college/ university as a full time student.
- Provide a notice of acceptance or tuition receipt for the coming scholastic year.
- Provide a wallet-size color photo.

Applicants must meet all criteria and provide data indicated above to be eligible. Incomplete applications or those missing data requirements will not be considered. All materials become the property of the LPSCU and will not be returned. **Applications must be postmarked by June 30, 2012.**

Two 2012 Slovakia Heritage Tours will offer participants a chance to explore Slovakia up close and personal as part of a small-group, relaxed-pace, 10-day tour.

# Cooking Corner

#### **SEAFOOD LASAGNA**

8 lasagna noodles

1 cup chopped onions

2 Tbsp. butter

8 oz. softened cream cheese

12 oz. creamed cottage cheese

1 beaten egg

¼ cup Parmesan cheese 2 tsp. crushed basil

½ tsp. salt

1/8 tsp. pepper

22 oz. cream of mushroom soup

1/3 cup milk

1/3 cup dry white wine

1 lb. shrimp, cooked

& halved

7½ oz. crabmeat, drained, flaked & cartilage removed

½ cup sharp cheese, shredded

Cook noodles. Place 4 noodles on 13x9x2 inch greased dish. Saute onions in butter. Blend in cream cheese. Stir in cottage cheese, egg, basil, salt and pepper. Spread one-half of mixture on top of noodles. Combine soup, milk, and wine. Stir in shrimp and crab. Spread one-half over cottage cheese layer. Repeat layers

of noodles, cottage cheese, and seafood mixture. Sprinkle with Parmesan cheese. Bake uncovered at 350 degrees for 45 minutes. Top with shredded cheese and bake 2 to 3 minutes more. Let stand 15 minutes before serving.

# CALL TO THE 40<sup>TH</sup> NATIONAL LPSCU CONVENTION

#### JUNE 24-27, 2012 POCONO MANOR, PENNSYLVANIA

In accordance with Article 50 sub-section (k), I hereby issue a call for the 40th National Convention of the Ladies Pennsylvania Slovak Catholic Union to convene on Sunday, June 24, 2012, at the Inn at Pocono Manor, Pocono Manor, Pennsylvania. Registration of delegates will begin Saturday, June 23, at a time to be announced.

#### **CONVENTION**

<u>Article 60</u>. The Convention is the highest legislative body of the organization.

<u>Article 61</u>. The Convention shall consist of the Board of Directors, Honorary Officers, Court of Appeals, and the delegates sent by various Branches.

#### **DELEGATES**

Article 64. Each Branch in good standing, which has at least 10 members, shall be entitled to have a delegate at the Convention who shall receive traveling expenses and such allowance per day as the Branch shall fix. Any one Branch may have no more than fifteen (15) delegates.

Article 65. Each Branch sends its delegates to the Convention at its own expense. The LPSCU, however, shall pay their hotel and meals during the time spent at the Convention. Each Branch having between 10 and 50 members, inclusive, is entitled to one delegate; 50 plus 1 members – two delegates; 100 plus 1 members – three delegates; 150 plus 1 members – four delegates, etc. The delegate must be elected by a majority of the members present at a regular Branch meeting. The delegate's application must be returned by the time designated. The number of members in good standing is designated according to the membership list held by the Secretary-Treasurer from the third month previous to the Convention.

Article 66. Each Branch shall have the opportunity to elect alternates to represent its Branch at the National Convention in the event of unforeseen circumstances preventing an elected delegate from attending the Convention.

Article 67. No person shall be recognized as a delegate unless the member is 18 years of age, an active member in good standing, and duly elected at the regular or special meeting of the Branch the member represents.

Article 68. The Convention shall be the sole judge of the qualifications of its delegates and may refuse or grant any person the right to sit as a delegate. However, the Credential Committee shall sit one day before the Convention and submit a report to the Convention.

# ATTENTION: ALL MEMBERS ASPIRING FOR LPSCU NATIONAL OFFICE

According to the Official Minutes of the Board of Directors' Semiannual Meeting held in Las Vegas, Nevada, on November 6-8, 2007, it is required that any member with aspirations for National Office must request an Intent Form from the Home Office. According to the LPSCU Bylaws, the qualifications for candidates are set forth in the following Articles:

Article 16. A candidate for office must be at least 21 years of age, an active member with participation in LPSCU Branch or District activities for at least five years, and be present as a delegate at the Convention.

Article 17. No two immediate family members shall serve as an Officer of the LPSCU during the same term of office. Immediate family is defined as: grandparent, parent, spouse, or sibling.

<u>Article 18</u>. A member or delegate, who is a National Officer/Director/Board Member of another fraternal benefit society, may not hold office of the LPSCU.

<u>Article 26</u>. No hired employee of the LPSCU shall be eligible to hold any National Office in the LPSCU while so employed, with the exception of the office of Secretary-Treasurer.

Article 27. Since the office of President is full time, nominations for this office will not be made from the floor. Nominations for the office of President shall be by written application which states the nominee's qualifications, personal background and history, as well as past experience. Nominee applications are to be submitted to the Home Office two months prior to the Convention. The Board of Directors shall verify these qualifications. They may use personal interviews, a professional investigating company, or any other means in order to verify the qualifications. From these applications, the Board of Directors shall recommend to the Nominating Committee candidates qualifying for the office of President.

Article 28. While nominations from the floor are to be accepted for all National Offices, excluding the office of National President and the hired position of Secretary-Treasurer, upon acceptance of the nomination, nominee will provide a resume to the delegates of the National Convention, containing personal background and history and past experience to prove their qualifications for the office to which they have been nominated.

The completed Intent Form must be returned to the Home Office with a postmark no later than May 1, 2012, with the exception of the Intent Form for the President's position, which must be returned to the Home Office with a postmark no later than April 13, 2012.

# Signatura to Hear Sacred Heart Appeal

The Apostolic Signatura (the highest court in the Vatican) agreed to hear the appeal to keep Sacred Heart of Jesus Church of Wilkes-Barre, Pennsylvania, open. A preliminary letter sent by the Secretary of the Apostolic Signatura concluded with the simple statement: "Please note that the recourse regarding the Church of the Sacred Heart is proceeding."

Historically, few appeals are accepted to be heard by this "Supreme Court of Rome." The appeals are studied when they arrive in Rome and the decision to allow the case to proceed is determined by a group of canon lawyers. Most are rejected "at the doorstep" (*e limine*). The Foundation will receive a formal announcement of the details of the hearing within two weeks. The only laity allowed in the court will be the Foundation's canon lawyers, Alessa and Carlo Gullo.

- All articles must be type-written, double-spaced, in Microsoft WORD format in 12 point, Times New Roman font.
- It is strongly preferred that English articles be e-mailed to Sister Bernadette Marie Ondus, SS.C.M, Editor, at: <a href="mailto:bernsscm@yahoo.com">bernsscm@yahoo.com</a>. In this age of modern technology, it is faster and more cost effective to work from a text that is provided digitally instead of having to retype the entire article.
- If it is not possible for an article to be e-mailed, a "hard copy" may be mailed to Sister Bernadette at Villa Sacred Heart, Danville, PA 17821-1698. Please do not send photocopies of articles.
- To be accepted for publication, articles must be between three and ten typewritten pages. Articles fewer than three pages or beyond ten pages will not be accepted.

#### **USE OF PHOTOS**

- If at all possible, kindly send photos to accompany articles. Photos must be included at the same time the article is sent to the Editor. (If sending photos digitally, save as separate JPGs to accompany the article.) Please indicate where photos are to be placed within the body of the article. Be sure to properly identify the persons, places and/or situations depicted in the photo(s). If no indication is given as to where, within the article, the photos are to be inserted, the photos will not be used.
- In the event that an article is e-mailed and photos are not included as attachments, the actual photographs, along with a hard copy of the article, must be mailed to Sister Bernadette Marie for inclusion in the article. - Slovak articles can be e-mailed to Sister Bernadette Marie, but a hard
  copy (including all accents) must <u>also</u> be mailed to her. (Please indicate
  that the article was both mailed and emailed.) Frequently, accent marks,
  diacritical characters, and other special characters do not come through
  properly when articles are e-mailed. Having a hard copy of the article,
  appropriately marked, will save valuable time and minimize errors.

Since its inception, this Appeal has raised \$2,272,737.74! Funds raised from the Appeal will aid the priest-graduate students at the Pontifical Slovak College of SS. Cyril and Methodius. These fine priests are being called upon to be the future leaders of the diocesan churches in Slovakia both as vicars and bishops, in addition to providing qualified instructors/professors for the seminaries that educate future priests. As well, funds benefit those religious communities of both men and women which share a counterpart which belongs to the Slovak Catholic Federation and the Slovak Conference of Religious. These communities include the Vincentian Sisters of Charity (Ruzomberok); Dominican Sisters (Dunajska Luzna); School Sisters of St. Francis (Zilina); Daughters of St. Francis (Bratislava-Prievoz); Byzantine Catholic Sisters of St. Basil the Great (Secove and Presov). Franciscan Friars Minor (Bratislava), and House of St. Benedict (Bacurov).

The Slovak Catholic Federation was founded in 1911 under the spiritual leadership of Rev. Joseph Murgas, founding pastor of Sacred Heart of Jesus Slovak Church, Wilkes-Barre, Pennsylvania . The purpose of the Federation is to federate individuals of Slovak origin under one banner for cultural, religious, and educational needs. Serving as National President is Rev. Philip Altavilla, V.G., Vicar General and Moderator of the Curia of the Diocese of Scranton. The Episcopal Moderator is the Most Rev. Joseph V. Adamec, D.D. The National First Vice President, Rev. Andrew S. Hvozdovic, pastor of Epiphany Parish, Sayre, Pennsylvania, is the coordinator for this annual Appeal.

In our Church today, we are finding that more and more individuals of Slovak descent/background do not attend traditionally founded Slovak parishes, for a number of reasons. Because of this reality today, the monies raised for this Appeal come both from the collections taken in our Slovak parishes as well as from individual donors.

# **Dear Junior Members,**

March is Red Cross Month, as proclaimed each year by the President of the United States. But do you know how this tradition came about?

From its creation by Clara Barton in 1881, the American Red Cross was largely dependent on the generosity of people who came forward to donate to the organization upon hearing of a catastrophic event that occurred somewhere in the country. Donations of supplies, money, and time were strictly based on the good will of citizens touched by the misfortune of their fellow Americans. This changed in 1917 with

the U.S. involvement in World War I. After war was declared, President Wilson ordered the Red Cross to raise funds to support its aid to those affected by the war, military and civilians alike. This resulted in the Red Cross's first national War Fund drive with a goal to raise \$100 million. Although this was an astonishingly large amount of money at the time, the public responded swiftly and generously. The drive was so successful that the Red Cross made it an annual event, combining it into a membership and fundraising drive.

With the Japanese attack on Pearl Harbor and the subsequent U.S. entrance into World War II, the Red Cross established a War Fund campaign, raising more than \$66 million between December 1941 and June 1942. It was in 1942 that President Franklin D. Roosevelt, the honorary chairman of the Red Cross, declared the whole month of March 1943 to be "Red Cross Month." The Red Cross set a goal of \$125 million, the largest amount ever requested in one campaign by any American organization. Again, the American people responded generously and the goal was reached in less than six weeks. Every year since, each American president has issued a similar proclamation.

You have seen stories of how the Red Cross has helped victims of Hurricane Katrina, and countless other tornadoes, storms, floods, fires, and other natural disasters. Maybe you even know someone on your own community who has been helped by this wonderful humanitarian organization.

But how did all this start?

Clarissa Harlowe Barton – Clara, as she was known – was a true pioneer and humanitarian. Born on Christmas Day in 1821 in North Oxford, Massachusetts, she was a shy and fearful child with a lisp, the youngest of five children in the Barton family. Her parents sent her to a boarding school, but she had such a difficult time adjusting that her parents brought her home. When she was 11, her brother, David, fell from a barn roof and was seriously injured. Clara surprised her parents by offering to care for him. She nursed him for two years, learning much about medicine in the process.

After her brother recovered, Clara tried school again. This time she overcame her fears and had a wonderful time with her classmates. They called her "little nurse" for her help with injured animals and sick cousins during a diphtheria epidemic.

Clara followed the lead of her older sisters and became a school teacher at 17. At a time when most people had to pay to send their children to school, Clara later founded one of the first public schools in New Jersey so that even the



children of the poor would be able to get an education. However, Clara taught school in an era when most teachers were men, and when a man was chosen over her to be principal at the school she had established, she left teaching to take a job as one of the first women clerks in the U.S. Patent Office in Washington, D.C., making her one of the first women to gain employment in the federal government.

At nearly 40 years old, Clara risked her life to bring supplies and support to soldiers in the field during the Civil War. It was here, caring for wounded and dying soldiers, that

she received the name "the Angel of the Battlefield." She also worked to identify the bodies of dead soldiers so their families could have closure.

After the war, she visited friends in Geneva, Switzerland, to recover her spirits and her health. While she was there, the founders of the International Red Cross asked her to help start an American branch. She returned home at age 60 to establish the American Red Cross in 1881, and served as its first president for 23 years.

With Clara at its head, the American Red Cross devoted itself largely to disaster relief for the first 20 years of its existence. The Red Cross flag was flown officially for the first time in this country in 1881 when Clara issued a public appeal for funds and clothing to aid victims of a devastating forest fire in Michigan. In 1884, she chartered steamers to carry needed supplies up and down the Ohio and Mississippi rivers to assist flood victims. In 1889, she and 50 volunteers rode the first train into Johnstown, Pennsylvania, to help the survivors of a dam break that caused 2,200 deaths. By the personal example she set, she opened paths to the new field of volunteer service.

From a shy little girl who lisped, Clara Barton became a teacher, government worker, battlefield nurse, finder of missing persons, and founder of one of the country's largest humanitarian organizations. She died on April 12, 1921, at the age of 91. The American Red Cross – her greatest achievement – lives on.

### **Arts and Crafts**

#### **MAKING FAMILY MEMORIES**

Creating this family tradition will be fun. You can start with a small family gathering and it will grow nicely. You will need a plain white cloth tablecloth or a large white sheet. Make sure it is washable.

After a holiday meal or family gathering, have each person present sign the tablecloth lightly in pencil or with a washable fabric marker. Encourage them to add comments or simple line drawings about the event – an Easter egg, a birthday cake, a Valentine heart, etc. And pencil in the date of the gathering.

Before washing the tablecloth, embroider over the pencil marks with thread or fine yarn. Make sure to use thread/yarn whose colors will not run when they get wet. Use all the same color for a single event. Then wash the tablecloth to remove the pencil marks.

Now you have started a special family tradition. Pull the tablecloth out for the next family get-together and have those present again sign it and draw a design. Again, use all one color of thread to embroider over the markings from that gathering. Be sure to add the date.

Over time, you will have a colorful remembrance of many happy times shared with your family.

### Did You Know?

Easter is always the 1st Sunday after the 1st full moon after the Spring Equinox. This dating of Easter is based on the lunar calendar that Hebrews used to identify Passover.

In 2008, Easter fell on March 23rd. That was the earliest Easter any of us will ever see for the rest of our lives. Only the most elderly of our population have ever seen it fall that early. The last time it was this early was 1913, so if



you're 95 or older, you are among the very few who have seen this occurrence twice in your lifetime. The next time Easter will be on March 23rd will be the year 2228 (216 years from now).

The next time Easter will be a day earlier – March 22nd – will be in the year 2285 (273 years from now). The last time it fell on March 22 was 1818. No one alive today has or ever will see it any earlier than it was in 2008.

Palm Sunday is celebrated the week before Easter. This year it falls on April 1st. It is the first day of Holy Week, the day we celebrate the story of Jesus' triumphant entry into Jerusalem. This can be traced back at least to the 4th century.

Easter Sunday is on April 8th this year. Easter is a Christian holiday commemorating the resurrection of Jesus from the dead. It is a legal holiday in most countries with a significant Christian tradition. Many countries celebrate Easter on Sunday as well as Easter Monday.

### **Easter Food Traditions**

When our Slovak ancestors arrived in this country a century ago, they brought with them beautiful and meaning-

ful traditions. Among the most popular is the tradition of blessing Easter food.

After a Lent of strict fasting and abstinence, Slovaks enjoyed specially prepared foods on Easter morning. Prepared in advance, these Easter breakfast dishes were placed in a basket and covered with a special, hand embroidered cloth. They were then taken to the church to be blessed before

the family enjoyed them at home.

The basket contained . . .

- brightly colored eggs, the symbol of new life, the life Jesus gave by rising from the dead.
- **Pascha**, a sweet yeast bread rich in eggs and butter.
- Other breads including nut and poppy seed rolls known as kolac.
- Klobasa and ham, a hearty main dish much enjoyed after a month of abstinence. To Slovaks, this dish is a sign of abundance. Some people prefer lamb or veal.
- An Easter cheese is known as syrek, with a rather bland, but sweet taste.
- **Horseradish**, a tall plant with a white, hot tasting root. This is ground and mixed with **beets** to make a dish called **chren**, to remind us of how bitter life would be without Jesus, and also of the bitter drink given to Jesus on the cross.
- Butter which is shaped into the figure of a lamb representing Jesus who is the Lamb of God.
- Salt is also blessed because it was used to preserve food and this symbolizes the fact that Jesus preserves us to eternal life.

This custom of blessing Easter food is still observed today in many Slovak and Slavic churches.

## Kids in the Kitchen

#### A SALAD FOR ONE

1 apple

2 tablespoons cottage cheese

5 or 6 raisins

2 or 3 nuts, chopped

1 teaspoon low fat mayonnaise

Cut the top off the apple. Core it almost all the way through, leaving the bottom skin over the hole. Scoop out the pulp of the apple and chop it up with cottage cheese, raisins, and nuts. Mix with mayonnaise. Stuff the mixture into the apple shell and put the top on it. This recipe is for one, but you can increase this to as many as you want.

Through our acknowledgement of where we have failed and through our true sorrow for our failures, we are invited by God to let go of our sins. We are encouraged not to hold on to unhealthy guilt. Sacramental absolution allows us to bury the past and grants us a new beginning, a fresh chance to live the life we are called to live as children of God. God's forgiveness is the gift which enables us to see ourselves and others as valuable human beings.

During our "travels" this Lent, may we avoid visiting Regret City or attending an unhealthy "Pity Party" and, through the power of God's mercy, may we frequently visit the land of "Starting Over," knowing and believing that we are forgiven and that we are saved!
