



## LPSCU Announces the **LYNDA (POSIVAK) MOHLENHOFF MEMORIAL AWARD**

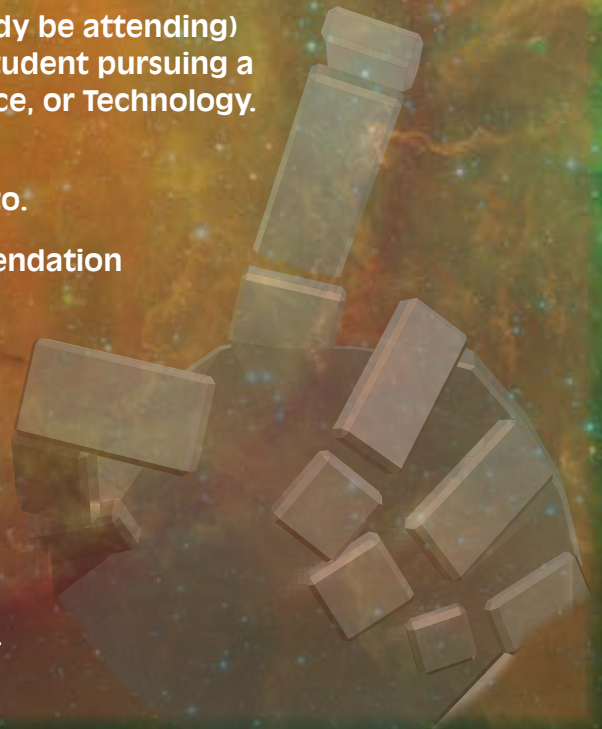
The LPSCU is proud to announce a NEW Scholarship for students pursuing a degree in or relating to the fields of Math, Science, or Technology. This scholarship, given in memory of Lynda (Posivak) Mohlenhoff, who was a member of LPSCU Branch 83 in Bethlehem, Pennsylvania, is funded entirely through the generosity of Lynda's parents, Peggy and Frank Posivak, who are also members of Branch 83. One lucky qualified applicant will be chosen for the \$500 award each year. The winner will be selected by a random drawing from among all qualified applicants. (Note: No individual shall be eligible to receive the scholarship more than two times.)

Any LPSCU member may apply, regardless of the amount or type of life insurance they have, but they must meet the following criteria to be eligible for this memorial award:

- Applicants must be accepted to attend (or already be attending) an accredited college/university as a full-time student pursuing a degree in or relating to the fields of Math, Science, or Technology. Proof of acceptance/attendance is required.
- Applicants must provide a wallet-size color photo.
- Applicants must provide two letters of recommendation from a teacher, friend, or religious affiliation.

To be eligible to receive this year's award, applications must be postmarked by August 15. ## BISHOP ANDREW G. GRUTKA MEMORIAL SCHOLARSHIP AWARD

\$1,000 AWARD

(Maximum of \$2,000 per member)

The LPSCU is proud to once again offer the Bishop Andrew G. Grutka Memorial Scholarship Award for lay persons between the ages of 18 to 35. This award, implemented at the 37th National Convention held in Merrillville, Indiana, in August 2000, is given in memory of Bishop Andrew G. Grutka, an outstanding Slovak leader who was the founding Bishop of the Diocese of Gary, Indiana.

Those applying for the Bishop Andrew G. Grutka Memorial Scholarship Award must meet the following criteria:

- Be a member of the LPSCU for two (2) years with \$5,000 permanent reserve life insurance certificate (excludes term insurance).
- Be a lay person between 18-35 years of age.
- Be of the Catholic religion (Latin Rite or Byzantine).
- Be initiated fully into the Church (Baptized, Eucharist, and Confirmed) and continuing to be eligible to receive the sacraments of the Church.
- Be a member of a Catholic parish.
- Be active in parish/diocesan/campus ministry as a lector, extraordinary minister of Holy Communion, adult altar server, catechist/aide, member of parish RCIA/C Team, youth minister, member of the Parish Pastoral Council, Finance Council, and/or other parish committees or organizations.
- Provide a Sponsor Eligibility Form from their parish to show they are active Catholics.
- Be active in an organization or activity that promotes awareness of our Slovak heritage, culture, and traditions.
- Be endorsed by his or her pastor and LPSCU Branch Secretary, with additional endorsement provided by campus minister, youth minister or pastoral associate.

## Sister Maria Goretti Hudak, SS.C.M.

Sister Maria Goretti (Anna Marie Hudak) was born on December 15, 1929, in Hazleton, Pennsylvania, the daughter of the late John and Anna (Jancar [Johnson]) Hudak. She attended St. Joseph School and graduated from Hazleton Senior High School. Before entering the Sisters of Saints Cyril and Methodius, Anna Marie worked in the office of the *Plain Speaker-Standard Sentinel* as a stenographer-bookkeeper.



After entering the congregation in Danville on February 2, 1950, she was received as a novice on August 10, 1950, and professed her vows on August 13, 1952. Sister pursued higher education and received a B.S. in Business Administration from Marywood University, Scranton, an M.B.A. from the University of Notre Dame in Indiana, and an M.Div. from the Immaculate Conception Seminary, Seton Hall University, New Jersey.

Sister began her teaching ministry in the fourth grade at Holy Trinity School, Perth Amboy, New Jersey. Later she taught at St. Cyril Academy, Danville, and also worked in the school office. Sister also taught novices and directed aspirants, young women seeking to discern a religious vocation. In two local parishes, she served as director of religious education programs. Later, she became Director of Associates, women who participated in promoting and assisting in the ministries of the Sisters.

After teaching in the business department at Andean High School, Merrillville, Indiana, for ten years and serving on Diocesan Committees, notably as president of the Pastoral Council of the Diocese of Gary, Indiana, Sister Maria Goretti assumed the position of Pastoral Assistant at St. Catherine Laboure Parish, Harrisburg, Pennsylvania. Here she served the Diocese in a variety of leadership roles, very often as president, notably of the Sisters' Council Liturgy Committee, Evangelization Committee, Ecumenical Committee, and the Vocation Committee. In 1988, Sister Maria Goretti became a member of the Congregation's Leadership Team, a post she held until 1996. From 1996 until 2009, Sister was the force behind the growth of the Maria Joseph Continuing Care Community, acting in various capacities, as treasurer, Development Director, and Associate Director at the various facilities, Maria Joseph Manor, Emmanuel, and The Meadows.

Besides her ministry in her religious congregation, Sister Maria Goretti was well known for her outreach to charitable and religious organizations in the Danville area. She was a pastoral visitor at the Danville State Hospital and served as president of the Danville-Riverside Ministerium Association (DRAMA), and as treasurer of the Danville-Riverside Area Christian Ministerium and the Good Samaritan Fund. Sister also served on the board of the Danville Chapter of the American Red Cross and was a member of the Geisinger Medical Pastoral Care Advisory Committee.

Sister Maria Goretti is survived by several nieces and nephews. The transferal rite took place on Tuesday, February 20, 2018, followed by the recitation of the Rosary and the Wake Service in the Maria Hall Chapel in Danville. The Mass of Christian Burial was celebrated in the Chapel at Maria Hall by Reverend Gerard Heintzelman. Burial was in the Sisters' cemetery.

# Cooking Corner

## PIROHY

### Dough

2 cups flour  
1 egg

1 tsp. salt  
8 oz. sour cream

Combine all ingredients. (I used my food processor with the dough blade.) Process or mix until dough forms a ball. The dough will be a bit tacky but just add a sprinkling of flour to make it more manageable. Turn dough out onto a floured board and knead for a few minutes until smooth and elastic. Wrap dough in plastic wrap and let rest in refrigerator for at least 1 hour. (This is a very important step.)

### Potato and Cheese Filling

I use a bag of the Ore Ida Steam 'n' Mash potatoes. (In the freezer section of the grocery store near the frozen French fries.) There are several varieties; I use the plain russet kind. Microwave as per the directions on the bag (10 minutes). When done, empty bag into a large bowl and add whatever you like to flavor them. (I use some butter to taste and mainly American cheese but I have mixed in some Cooper Sharp to give the mixture some tang.) Put in as much cheese as you like, tasting as you go along.

When dough has rested for 1 hour, turn it onto a floured board. Take off a section at a time and roll it out fairly thin. You don't want it so thin that it breaks open, but not too thick either. I roll it out just enough that I can almost see my hand through the dough. (You'll figure it out after a few times.)

The rolled dough can be portioned out in two ways. Use a round cutter to make a circle, which you fill with a small scoop of potato mixture. (I use a 2 oz. measure.) Fold in half and pinch to close tightly. (You can use a little flour on your fingers to ensure a tight seal or use the back of a fork to seal.) The problem with a round cutter is waste. You can collect the scraps and re-roll them, but it is tedious and the dough becomes tough if you re-roll more than once. I use a pizza cutter to make squares. It is a little tricky to fold them, but there is no waste to deal with. Just bring 2 corners together and pinch to seal. I roll out all the dough, fill and seal, and let them sit on a clean tablecloth.

Drop a batch (I do 12 at a time) into a pot of boiling, salted water. Let them boil until they rise to the top. (Taste a corner to determine doneness.) Drain, and put them into a container with sautéed butter and onions. That's pretty much it...Enjoy!

# Pittsburgh Agreement Celebration Planned

On Thursday, May 31, 2018, the 100th anniversary of the signing of the Pittsburgh Agreement will be celebrated with a commemorative program at the Heinz History Center in Pittsburgh, Pennsylvania. The program, which will begin at 6:00 p.m., will feature presentations by various government officials from the Czech Republic and Slovakia, as well as local officials. A reception will follow the formal program.

The signing of the Pittsburgh Agreement on May 31, 1918, was an important occurrence in the course of events leading to the establishment of an independent Czechoslovak state after the First World War. The catalyst for drafting and signing of this agreement was the visit to Pittsburgh of Professor Thomas Masaryk, who later became the first President of Czechoslovakia. The agreement was also signed by leaders of local and national Slovak and Czech fraternal organizations.

Admission for this memorable event is \$35.00 per person. (NO tickets will be printed.) 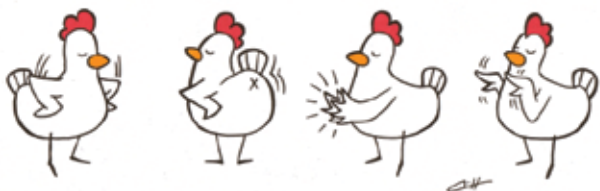
## Dance Like a Chicken

## Slovak Hockey Star

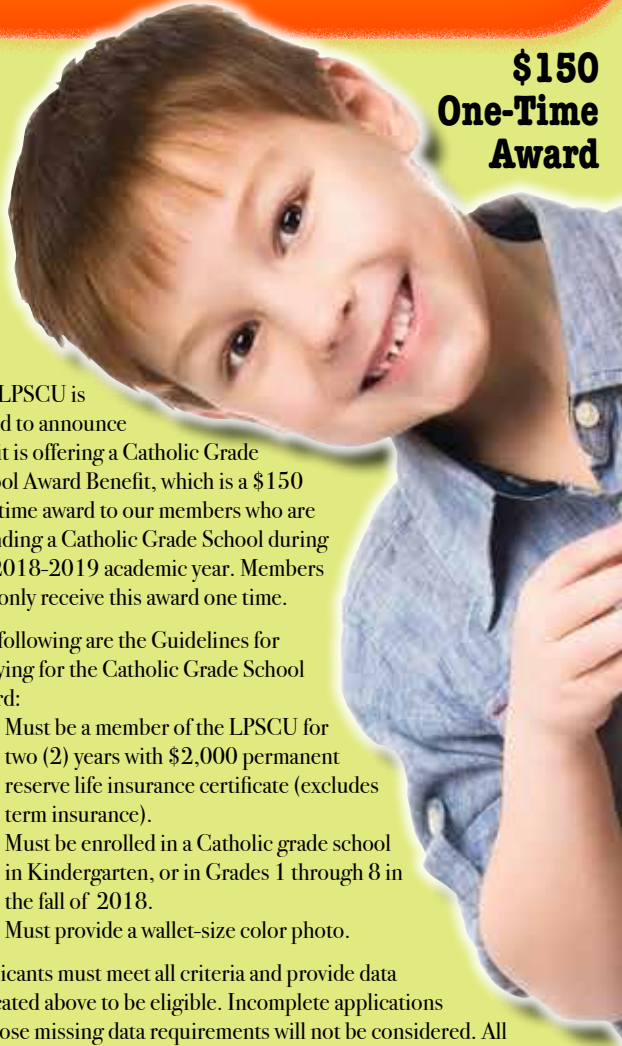
**Milan Jurčina** is a Slovak professional ice hockey defenseman who currently plays for the Thomas Sabo Ice Tigers in Nuremberg, Germany. His offensive capabilities rely on his very hard slapshot, making him a threat on the power play. Born on June 7, 1983, the 6-ft. 4-in. Jurčina played in the U.S. for the Boston Bruins, the Washington Capitals, the Columbus Blue Jackets, and the New York Islanders from 2005 through 2011. He was also a member of the Slovak hockey team that played in the 2010 Winter Olympics in Vancouver, Canada. Slovakia finished fourth in that contest.

On August 22, 2014, Jurčina joined Dinamo Riga of the Kontinental Hockey League (KHL). He remained in the KHL in 2015-16, but took his game to Croatia, suiting up for Medveščak Zagreb. He made 49 appearances for the club, scoring four goals while assisting on ten more. On February 15, 2016, he signed a contract with Eisbären Berlin of the German top-tier Deutsche Eishockey Liga for the remainder of the 2015-16 season. In September 2016, he signed a deal with the Nürnberg Ice Tigers, where he continues to play today.

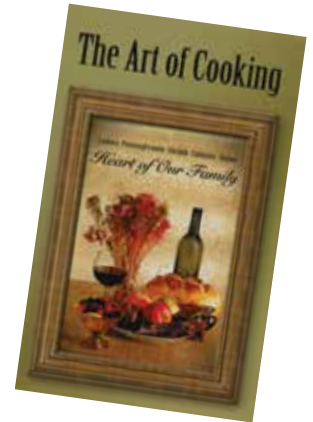
