FRIDAY, JUNE 14, 2025

*Annual Pause for
the Pledge of Allegiance
to the U.S. Flag*



WHEREAS, by Act of Congress of the United States dated June 14, 1777, the first official flag of the United States was adopted, and

WHEREAS, by Act of Congress dated August 3, 1949, June 14 of each year has been designated National Flag Day, and

WHEREAS, on December 8, 1982, the National Flag Day Foundation was chartered to conduct educational programs and to encourage all Americans to Pause for the Pledge of Allegiance on National Flag Day, June 14, and

WHEREAS, by Act of Congress, Public Law 99-54 was passed to have the Pause for the Pledge of Allegiance as part of the celebration of National Flag Day throughout the nation, and

WHEREAS, National Flag Day celebrates our nation's symbol of unity, a democracy in a republic, and stands for our country's devotion to freedom, to the rule of law, and to equal rights for all,

NOW, THEREFORE, I, Theresa A. Kluchinski, national president, do hereby proclaim June 14, 2025, as National Flag Day and urge all members of the Ladies Pennsylvania Slovak Catholic Union to pause at 7 p.m. Eastern Time on this date for the 42nd annual Pause for the Pledge of Allegiance to the United States Flag and our great nation.

BISHOP ANDREW G. GRUTKA MEMORIAL SCHOLARSHIP AWARD \$1,000 AWARD (Maximum of \$2,000 per member)

The LPSCU is proud to once again offer the Bishop Andrew G. Grutka Memorial Scholarship Award for lay persons between the ages of 18 to 35. This award, implemented at the 37th National Convention held in Merrillville, Indiana, in August 2000, is given in memory of Bishop Andrew G. Grutka, an outstanding Slovak leader who was the founding Bishop of the Diocese of Gary, Indiana.

Those applying for the Bishop Andrew G. Grutka Memorial Scholarship Award must meet the following criteria:

- Be a member of the LPSCU for two (2) years with \$5,000 permanent reserve life insurance certificate (excludes term insurance).
- Be a lay person between 18-35 years of age.
- Be of the Catholic religion (Latin Rite or Byzantine).
- Be initiated fully into the Church (Baptized, Eucharist, and Confirmed) and continuing to be eligible to receive the sacraments of the Church.
- Be a member of a Catholic parish.
- Be active in parish/diocesan/campus ministry as a lector, extraordinary minister of Holy Communion, adult altar server, catechist/aide, member of parish RCIA/C Team, youth minister, member of the Parish Pastoral Council, Finance Council, and/or other parish committees or organizations.
- Provide a Sponsor Eligibility Form from their parish to show they are active Catholics.
- Be active in an organization or activity that promotes awareness of our Slovak heritage, culture, and traditions.
- Be endorsed by his or her pastor and LPSCU Branch Secretary, with additional endorsement provided by campus minister, youth minister or pastoral associate.
- Attend (or will attend) an accredited college/university as a full time student.
- Provide a notice of acceptance or tuition receipt for the coming scholastic year.
- Provide a wallet-size or digital color photo.

Applicants must meet all criteria and provide data indicated above to be eligible. Incomplete applications or those missing data requirements will not be considered. All materials become the property of the LPSCU and will not be returned. **Applications must be postmarked by June 30, 2025.**



- ❖ Provide a wallet-size or digital color photo with the application.
- ❖ Re-apply each year while attending/completing studies for Religious Life in order to receive the award each year of his/her religious training.

Applicants must meet all criteria outlined and provide data indicated to be eligible. Incomplete applications or those missing data requirements will not be considered. All materials become the property of the LPSCU and will not be returned.

Applications are available from the LPSCU Home Office or its website. **Applications for the 2025 awards must be postmarked by August 31, 2025.**

Executive Finance Committee Meeting Minutes

February 19, 2025 ❖ Home Office, Wilkes-Barre, Pennsylvania

President Theresa Kluchinski called the meeting to order, lead the members of the committee in saying the Pledge of Allegiance to the Flag, and offered a prayer. All members of the Executive Finance Committee were present.

Minutes

The committee reviewed and accepted the minutes of the November 20, 2024, EFC meeting.

Correspondence/Requests

Correspondence

- ❖ A thank you was received from UPMC Children's Foundation for the donation made through Fraternal Societies of Greater Pittsburgh.
- ❖ A notice was received indicating that the annual workman's compensation audit will be conducted in March.

Requests

- ❖ Benedictine High School – Request for sponsorship associated with the Blue and White Gala. After discussion, the committee reached a consensus to donate.

Financial Statement Review

The EFC members were provided with various statements and records associated with the banking, investments, and financial statements for the months of October, November, and December 2024 in addition to January 2025. The various documents were reviewed and discussed.

- ❖ M&T Bank Account Statements – The staff is continuing work on contacting recipients of outstanding checks which is reducing the list. The staff also encountered some reconciliation problems with the method of posting checks to the new software. This problem has been resolved.
- ❖ Morgan Stanley Checking – The EFC reviewed the monthly statements and reconciliation for the months of October, November, and December 2024. During the review, the EFC noted that the only transactions were transfers to the regular checking. Also noted was the deposit of CD interest and mutual fund dividend distributions.
- ❖ Home Office Branch Deposit Account – A statement showing the interest earned and balance as of December 31, 2024, was distributed prior to the meeting. President Kluchinski noted interest paid, one deposit made, and the balance in the account as of December 31, 2024.
- ❖ Financial Graphs – President Kluchinski reviewed the financial graphs distributed prior to the meeting. She noted changes in the various graphs and provided some detail regarding the cause of the changes.
- ❖ Annual Statement – Secretary-Treasurer Andrzejewski reviewed the Preliminary Annual Statement results with the EFC. Increases and decreases in the assets, liabilities, and surplus were pointed out. Revenue and expenses were discussed as a part of the Summary of Operations. The committee noted the net capital gain resulting from various investment sales during the year.

- ❖ Balance Sheet and Profit/Loss Comparison – A report for January through December was distributed to the EFC. The EFC members engaged in a discussion regarding the results reported in the investment portfolio. During the discussion President Kluchinski noted that there were bonds called and sold during 2024. Gains and losses were reviewed.

Investment Portfolio

The Market Value Sheet was distributed to the EFC members prior to the meeting. A review of market values of the portfolio as of January 2025 was conducted.

President Kluchinski began discussion about the investment portfolio by noting that a third sale of stock took place in December as authorized by the EFC. The sales brought the total stock holdings in line with the percentage of surplus goal. The cash raised by the sale was transferred to purchase bond investments. President Kluchinski reported that nine new bonds were purchased with the proceeds. Bonds maturing or which have been called were listed and the EFC engaged in discussion regarding future maturities.

The custodial statements and investment spreadsheets showing the activity in the managed stock and bond account were distributed to the committee. The individual stock sales were listed along with the gains and losses. The reports were used during the prior discussion about the investment portfolio.

Credit Card Statements

As per request of the EFC during the November meeting, the new credit card reconciliation was distributed to EFC members for their review. The report distributed consisted of a copy of the credit card statement and the General Ledger reconciliation made to distribute the expenses in the GL. The statements were reviewed with a short period of discussion about the use of the card. President Kluchinski noted the amount of cash back generated while using the card.

Pension Update

President Kluchinski reported that the LPSCU distributed the appropriate notices to the participants as instructed by the pension plan consultants. The letter distributed indicated the expected termination date and estimated distribution to the participants. A report was given on investment activity associated with the pension assets.

President Kluchinski also reported on the 401(k) profit sharing distribution. The distribution is scheduled to occur in March 2025.

Home Office

The Executive Officers reported on the following items associated with the Home Office operations:

- ❖ IT Risk Assessment – The IT risk assessment was completed, and a report was compiled for the LPSCU. The report was distributed to the members of the EFC for their review. The committee engaged in a discussion of the items noted in the report and the action to be taken to mitigate the items.

- ❖ *Zornicka* Postage Account – President Kluchinski reported that she has been spending time to correct a problem with the *Zornicka* postage account. She provided details regarding the problem and the action being taken to correct the problem.
- ❖ Cyber Insurance – Secretary-Treasurer Andrzejewski reported on information received regarding higher limits of cyber insurance protection. Higher limits were explored because of the latest insurance department exam. The proposed coverage was reviewed with the EFC as well as the cost of the coverage. The EFC engaged in discussion regarding the coverage. At the conclusion of the discussion, the EFC reached a consensus to direct the executive officers to purchase the coverage as presented.
- ❖ Building Maintenance Item – Secretary-Treasurer Andrzejewski reported that the annual drain line clean out has been scheduled.
- ❖ SharePoint – Secretary-Treasurer Andrzejewski reported that work is progressing to provide site access to the Board members.

2024 Budget

President Kluchinski distributed the budget sheet showing account balances as of December 31, 2024. The account balances allowed for a comparison between the actual results and the budget which was approved by the Board for 2024. The EFC engaged in discussion about the actual expenses and income shown on the budget, noting areas of variance which can be improved upon.

After reviewing the 2024 budget and concluding discussion, President Kluchinski distributed a copy of the 2024 budget in the new format that is planned to be used for the 2025 budget. The new format allows revenues and expenses to be tracked monthly and compared to the established budget numbers. As a part of the initial discussion about the 2025 budget, the EFC questioned the expense of the official publication. The committee agreed that additional information would be needed to consider cost-cutting decisions. No action was taken at this time.

Other Business

None

Meeting Dates

The next meeting will be on May 21, 2025, starting at 9:30 a.m.

There being no further business, the EFC adjourned.

LPSCU 2025 POST GRADUATE AWARD

The LPSCU is offering a Post Graduate Award Benefit to our members who are awarded a Master's or Doctorate degree during the period running from July 1, 2024, to August 30, 2025. Applicants must have a minimum of \$5,000 of insurance through the LPSCU in order to apply for the \$500 award. Applicants can increase their current face amount to meet the \$5,000 requirement.

Members who qualify may receive this award one time upon receiving their Master's degree and one time upon receiving their Doctorate. (Members must apply separately and provide all the required criteria if they wish to apply for both the Master's and Doctorate Post Graduate Awards.)

Following are the guidelines for applying for the Post Graduate Award. All applicants must:

- Be a member of the LPSCU for at least five years with a \$5,000 permanent reserve life insurance certificate. (Term insurance is excluded.)
- Provide a photocopy of the Master's and/or Doctorate degree received.
- Provide documentation that the degree was awarded between July 1, 2024 and August 30, 2025.
- Provide a wallet-size or digital color photo.

Applicants must meet all criteria outlined and provide data indicated in order to be eligible. Applications missing data or with incomplete requirements will not be considered. All materials become the property of the LPSCU and will not be returned.

LPSCU 10 Payment Life Insurance Plan

The LPSCU offers an economic and beneficial 10 Payment Life Insurance Plan for anyone from age 0 to 75. Under this plan, there is a minimum purchase requirement of life insurance. For those ages 0-70, the minimum purchase amount is \$5,000; for ages 71-75, the minimum purchase amount is \$2,000. Premiums are payable for ten (10) years from issue date. If the insured dies within the 10-year period following the issue date, no additional premiums are due and payable, and the face amount of the certificate is paid to the named beneficiary/ies, except as provided within the contract regarding Suicide and Contestability.

Premium payments can be made monthly, quarterly, semiannually, or annually. The certificate becomes fully paid at the end of ten years, and coverage remains in full force and effect for the entire life of the insured without any additional premium payments required. Upon the death of the insured, the face amount of the certificate is paid to the insured's named beneficiary/ies.

A member with a 10 Payment Life Plan is entitled to

all fraternal benefits of the LPSCU including educational awards, youth and adult activities, newborn benefits, prescription discount card, official publication, and discount car rental, to name a few.

The 10 Payment Life Plan is ideal for both youth and adults – particularly anyone who prefers to have their life insurance paid in full within ten years. Additionally, the 10 Payment Life Plan offered by the LPSCU is both economical and beneficial for estate planning and can especially help with the ever-increasing cost of funeral expenses.

To apply for this specific plan, or any other insurance plan offered by the LPSCU, contact your Branch Secretary or the LPSCU Home Office.

SS.C.M. Appeal Update

Focusing on National Awareness Month

MAY National Hearing Month

The focus of May's monthly awareness is better hearing. Hearing has always been a health focus dating as far back as 1927. It was then that the American Speech-Language-Hearing Association (ASHA) established a national month to raise awareness and provide helpful tips to preserve people's hearing.

ASHA has clear and well-defined objectives. These are:

- Increase public awareness about hearing loss.
- Encourage regular hearing screenings.
- Promote healthy hearing habits.
- Highlight the importance and role of audiologists.

Have you ever been in a large venue, such as a stadium for a music concert or sporting event, and the noise was so loud you couldn't hear a thing? Sound absurd? Or in a room full of people, you can see their mouths moving, but can't make out any discernable words? Unfortunately, statistics show that this happens every day to approximately 20% of the global population. Broken down into numbers, that's **1.5 billion people!** Specifically in the United States, one in eight people aged twelve and older has hearing loss in both ears based on standard hearing examinations. If you're a numbers person like I am, that's 13% of the United States population or 30 million people. It is estimated that in the age group of 65- to 74-year-olds, 25% have hearing loss in both ears. These are staggering numbers.

Whether you are the person with the hearing loss, or the one having to constantly repeat yourself because someone can't hear you, it's frustrating. My dad experienced major hearing loss due to noise levels he endured while working. His place

of employment provided ear plugs for the workers to reduce the effect of the noisy equipment, but my dad told me next to no one used them. We had countless conversations where his main sentence was, "I can't hear you."

Based on the numbers given above, I think it's safe to say that hearing loss is a common occurrence. Early detection is important. Many types of hearing loss can be treated through a variety of methods. The key is to have your hearing checked on a regular basis.

JUNE National Safety Month

June's awareness focus is on promoting safety in all aspects of life, from home to school to work. Any time one can make one of these areas safer, it is better in the long run.

Home safety measures that people can take usually focus on two areas: fire safety and general safety. Fire safety includes the usual things that most people think of: having working smoke detectors and fire extinguishers. But good home safety should also consist of an emergency exit plan. This plan should be practiced periodically to everyone knows what they are to do in an emergency situation. General safety refers to things such as having operable window and door locks, security cameras, doorbell cameras, and security lighting. Additionally, keeping floors dry and uncluttered, locking medicine cabinets, and if applicable, babyproofing your home are also ways to ensure the safety of you, your family and anyone visiting your home.

School safety has four main areas: physical security, prevention, mental well-being, and cybersecurity. Physical security ensures that measures such as access to buildings is monitored through surveillance systems and that emergency response protocols are in place. Prevention consists of anti-bullying policies and conducting regular safety drills. Mental well-being is ensuring students and staff have access to counseling services and that issues such as bullying and harassment are addressed and dealt with accordingly. Cybersecurity is the avenue where student information is protected. This area should also include measures to prevent cyberbullying.

Regarding workplace safety, there are three C's to keep in mind: compliance, competence, and commitment. Ensuring compliance is knowledge and enforcement of relevant regulations from organizations such as the Occupational Health and Safety Administration (OSHA). Developing competence is empowering employees to accurately assess risks and make informed decisions based on those risks. Commitment to safety means staying up to date as laws change and environments change within the workplace.

While many of us are aware of the majority of the items I touched on above, just repeating them and bringing them to the forefront of our thinking is a positive step. Safety is ever evolving and should be evaluated on a regular schedule to determine if any new methods and tools need to be implemented.

The purpose of these monthly awareness articles is to bring to the forefront issues that people deal with every day but probably don't think about on a daily basis. The better informed we are, the better we can react to situations when needed.

Cooking Corner

COOL SPAGHETTI SUMMER SALAD

- 1 lb. box thin spaghetti, pieces broken in half or thirds
- 16 oz. pkg. frozen chopped green bell peppers
- 2 sweet red onions, chopped
- 2 tomatoes, chopped, or 1 c. cherry tomatoes, halved
- ½ bottle Kraft Zesty Italian salad dressing
- 2 pkg. dry Italian dressing mix

Cook spaghetti, drain and cool. Mix together bell peppers, red onions, tomatoes, Zesty salad dressing, and dry Italian dressing mix. Add to drained spaghetti and toss. Keep cool in refrigerator. Mix before serving.

Optional:

Add 1 small can diced black olives or 1 celery stalk, diced.

For a sweeter taste, chop equal amounts of green, red, orange, and yellow bell peppers.

The largest events usually take place in Washington, D.C., Philadelphia, PA, Chicago, IL, and Los Angeles, CA.

The History of Flag Day

The first celebration of the U.S. Flag's birthday was held in 1877, on the 100th anniversary of the Flag Resolution of 1777. However, it is believed that the first annual recognition of the flag's birthday dates to 1885 when schoolteacher BJ Cigrand organized a group of Wisconsin students to observe June 14, the 108th anniversary of the official adoption of The Stars and Stripes, as the Flag's Birthday. Cigrand, now known as the Father of Flag Day, continued to publicly advocate the observance of June 14 as the flag's birthday, or "Flag Day," for years.

In 1916, the anniversary of the Flag Resolution of 1777 became a nationally observed event by a proclamation by President Woodrow Wilson. However, it was not designated as National Flag Day until August 3, 1949, when an Act of Congress designated June 14 of each year as National Flag Day.

Today, Flag Day is celebrated with parades, essay contests, ceremonies and picnics sponsored by veterans' groups, schools, and groups like the National Flag Day Foundation whose goal is to preserve the traditions, history, pride, and respect that are due the nation's symbol, Old Glory.


